Keynote Speakers

Arnaud Girod

Head of Economics and Cross-Asset Strategy, Kepler Cheuvreux

Arnaud – a Franco-Italian national – is Head of Economics and Cross-Asset Strategy. Prior to that, he was Co-Head of Institutional Research at Kepler Cheuvreux for eight years, working alongside Jose Hernandez and Mathieu Labille. During that time, he helped expand the company's stock coverage, which rose from around 400 to 1,000 stocks, and passionately promoted the values of independence and collaboration. He developed Das Research, the

company's quality standard, and in-depth research templates, as well as the video platform KC Discovery, and also led Kepler Cheuvreux's ESG integration project. Since 2013, Arnaud has also authored a hybrid top-down / bottom-up quarterly report that builds European high-conviction portfolios. He joined Kepler Cheuvreux in 2008 as an equity sales person selling European equities to UK investors. He started his career in 2001 with BNP Paribas in London after graduating from Paris Dauphine University with a master's degree (5 years) in Financial Markets.

Prof. Dr. Guntram Wolff

Director of the German Council on Foreign Relations

Guntram Wolff is the director of the German Council on Foreign Relations and a Professor at the Willy-Brandt School of public policy at the University Erfurt. From 2013 to 2022, he was director of Bruegel, a Brussels-based institute on economic policy in Europe, which he developed into a leading global think tank. His research focuses on European political economy, economic statecraft, deoeconomics, climate policy and Germany's

geopolitical strategy. His work has been published in academic journals such as Nature, Science, Journal of Banking and Finance. He is a seasoned public speaker and has participated in multiple panels with leading academics, policymakers, and C-level executives. He is often quoted by and contributes op-eds to several global media, including the New York Times, Financial Times, Bloomberg, The Guardian, Frankfurter Allgemeine Zeitung. In 2020, Business Insider ranked him as one of the 28 most influential power players in Europe. Since 2013, Wolff has been speaking twice a year to the Economic and Financial Affairs Council (ECOFIN), the informal meeting of the EU's finance ministers and central bank governors.



Dr. Janka Oertel Director of the Asia Programme at the European Council on Foreign

Relations (ECFR)

Dr. Janka Oertel is director of the Asia programme and a senior policy fellow at the European Council on Foreign Relations. Oertel previously worked as a senior fellow in the Asia programme at the German Marshall Fund of the United States' Berlin office, where she focused on transatlantic China policy including on emerging technologies, Chinese foreign policy,

and security in east Asia. Prior to joining the GMF, she served as a programme director at Körber Foundation's Berlin office. She was also a visiting fellow at the German Institute for International and Security Affairs (SWP Berlin) and worked at United Nations Headquarters, New York, as a Carlo-Schmid fellow. She has published widely on topics related to EU-China relations, US-China relations, security in the Asia-Pacific region, Chinese foreign policy, 5G and emerging technologies, as well as climate cooperation. She has testified before the US Senate Foreign Relations Committee and the German Bundestag and is frequently quoted in leading media outlets such as the *Financial Times*, the *New York Times*, *The Economist*, *Süddeutsche Zeitung*, *El Confidencial*, *Berlingske*, and many more. Her new book *"Ende der China-Illusion. Wie wir mit Pekings Machtanspruch umgehen müssen"* was published in August 2023 with Piper in Germany. Oertel holds a PhD from the University of Jena. Her dissertation focused on Chinese policies within the United Nations.


